



# Guidelines for Citing References at Faculty of Economics & Business, University of Zagreb

The Faculty of Economics & Business, University of Zagreb, in accordance with the respective study programmes, uses the APA style (American Psychological Association) for citing the lists of references in writing bachelor's, master's, and PhD theses in English. The examples of citing the most frequent types of sources are given hereafter. More information on the APA style is available at:

#### Important:

- 1. The style for citing references should be followed consistently. This includes all, even the minutest, elements of style font style (normal or italics and similar), punctuation, etc. Furthermore, relying on the citation software (if used at all) is insufficient; it is necessary to check the output.
- 2. The sources are cited in alphabetical order as a comprehensive list and not as groups of sources.
- 3. The country of publisher's location is never cited, except for the USA where the federal state is included in the abbreviated form (e.g., Boston, MA).

### Citing an authored book by up to seven authors

**Note:** All 7 names are fully cited.

The elements to be cited: 1. Last name(s) of author(s) followed by first name(s) initial(s), 2. Year of book publication, 3. Title of book, 4. Edition (if available), 5. Publishing house location, 6. Name of publisher.

## Citing an authored book by more than seven authors

The elements to be cited: 1. Last name(s) of author(s) followed by first name(s) initial(s), or name of institution, 2. Year of publication, 3. Title of book, 4. Edition (if available), 5. Publishing house location, 6. Name of publisher.

## Citing a book published by institution

The elements to be cited: 1. Name of institution, 2. Year of publication, 3. Title o book, 4. Edition (if available), 5. Publishing house headquarters location, 6. Name of publisher.

## Citing an electronic book or e-book

**Note:** An electronic book or an e-book is a book publication made available in electronic form exclusively. If the book is also available in printed form, the latter is cited and not the electronic publication.

The elements to be cited: 1. Last name(s) of author(s) followed by first name(s) initial(s), 2. Year of publication, 3. Title of book, 4. URL where book was published (website address where the e-book was retrieved from).

# Citing a chapter in an edited book

**Note:** Please refer to the title of the chapter, not to the book where it was published.

The elements to be cited: 1. Last name(s) of chapter author(s) followed by first name(s) initial(s), 2. Year of publication, 3. Title of chapter, 4. "In" indicating the book where the chapter is from, 5. Editor's last name(s) and first name(s) initial(s), 6. "Ed(s)" indicating editor(s), 7. Title of edited book, 8. Page range of chapter, 9. Publisher of edited book, 10. Location of publisher.

## Citing an article published in a journal

The elements to be cited: 1. Last name(s) of author(s) followed by first name(s) initial(s), 2. Year of publication, 3. Title of article, 4. Title of journal article was published in, 5. Volume of journal, 6. Issue number (in brackets), 7. Page range of article, 8. DOI of article (if available).

#### Citing an article published in conference proceedings

The elements to be cited: 1. Last name(s) of author(s) followed by first name(s) initial(s), 2. Year of publication, 3. Title of article, 4. "In" indicating that article was published in a proceedings, 5. Editor(s) last name(s) name(s), 6."Ed(s)" indicating one or more editor(s), 7. Title of proceedings, 8. Page range of article, 9. Location of proceedings publisher, 10. Name of publisher.

#### Citing an article published in an electronic journal

The elements to be cited: 1. Last name(s) of author(s) followed by first name(s) initial(s), 2. Year of publication and date of online publication (if available), 3. Title of article, 4. Journal title (if available), 5. Volume of journal and issue number (if available), 6. URL where article was published (website address where the article was retrieved from).

## Citing an authored article published in a working paper series

The elements to be cited: 1. Last name(s) of author(s) followed by first name(s) initial(s), 2. Year and month (if available) of online publication, 3. Title of article, 4. Title of working paper series, 5. Numerical mark or year/volume of publication or similar (if available), 6. Page range









of article, 7. URL where article was published (website address where the atricle was retrieved from).

#### Citing an article published on Internet

The elements to be cited: 1. Last name(s) of author(s) followed by first name(s) initial(s), 2. Year of publication on Internet, 3. Title of article, 4. Date of accessing article on Internet 5. URL where article was published (website address where the article was retrieved from).

#### Citing a document published on Internet

The elements to be cited: 1. Last name(s) of author(s) followed by first name(s) initial(s) or abbreviated name of institution, 2. Year of publication on Internet, 3. Title of document, 4. Indication of e-publication (EPub) 5. URL where document was published (website address where the document was retrieved from).

#### Citing a text from Internet

The elements to be cited: 1. Internet page name, 2. "n.d." indicating there is no date, 3. Title of text, 4. Date of retrieval from Internet page, 5. URL where text was published (website address where the text was retrieved from).

## Citing Internet database

The elements to be cited: 1. Name of organisation or Internet home page that founded database, 2. Retrieval year, 3. Name of database/document, 4. Indicate [Data file], 5. URL where database was published.

# Citing legislation

The elements to be cited: 1. Title of law, 2. Name and number of official source, 3. Year of first publication of law.

# Citing master's or PhD thesis

The elements to be cited: 1. Thesis author's last name and first name(s) initial(s), 2. Year of publication of thesis, 3. Title of thesis, 4. Type of work, 5. Name of institution where thesis was defended, 6. Location of institution.
